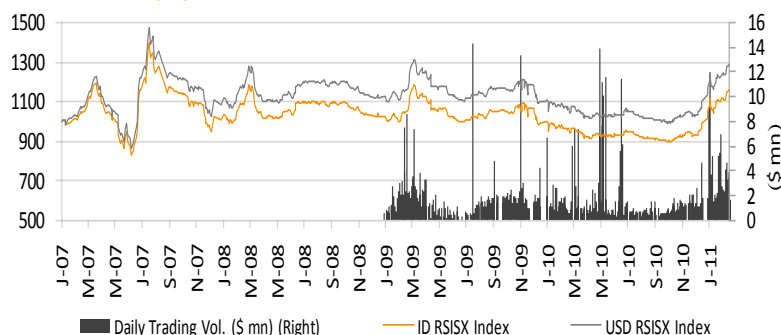

News from Iraq

Politics

- Protests in Iraq and across the Arab world show the need to resolve long-standing disputes between Arabs and Kurds in northern Iraq before they turn into a conflict, the United Nations' envoy to Iraq said on Tuesday. Melkert said the United Nations was working with officials in Baghdad and Kurdistan to try to set an agenda for addressing differences, including disputes over oil revenue-sharing and the future of the city of Kirkuk. Economics

- Iraq's total oil exports and revenues from crude sales in January both hit their highest levels since the 2003 US-led invasion which ousted Saddam Hussein, the oil ministry announced on Wednesday. Iraq exported a total of 67mn barrels of oil last month, generating \$6.082bn in income at an average price of \$90.78 a barrel, according to figures published by the ministry. (Zawya)
- The Iraqi Oil Ministry is expected to award this year a deal worth \$4bn to build a refinery in Kerbala province, south of Baghdad, Iraq's deputy prime minister for energy affairs said Wednesday. (Zawya)
- The head of the Investment Commission in Najaf said Tuesday that nine new investment licenses that worth more than \$660mn in the areas of housing, industry, agriculture and tourism were granted. (Zawya)
- A series of shopping malls, "City Center" reveals a plan to set up a huge shopping center in Basra at a cost of \$200mn. ((Aswat Al-Iraq))
- Fluor Corporation announced that ExxonMobil Iraq Limited has awarded the firm an early works program contract for the West Qurna (Phase I) field near Basra, Iraq. (Iraq Directory)

Daily Transactions in Brief

The Iraq Stock Exchange held the seventeenth session of the month today. 40 companies were able to trade in this session, and 13 companies were unable to do so mainly due to their General Assembly Meeting or ISX / ISC Instructions. The number of traded shares was 1.8bln and the trading volume was ID2.4bln (\$2.1mn).

Foreigners executed 131 buying transactions in 22 companies operating in banking, insurance, services and industry sectors, while their purchases amounted at ID877mn (\$749ths) and their share in total trading volume was 18.1%. According to trading volumes, the first three companies that were bought by foreigners were Mosul Bank (BMFI), Iraqi Middle East Investment Bank (BIME) and Baghdad Soft Drinks (IBSD).
