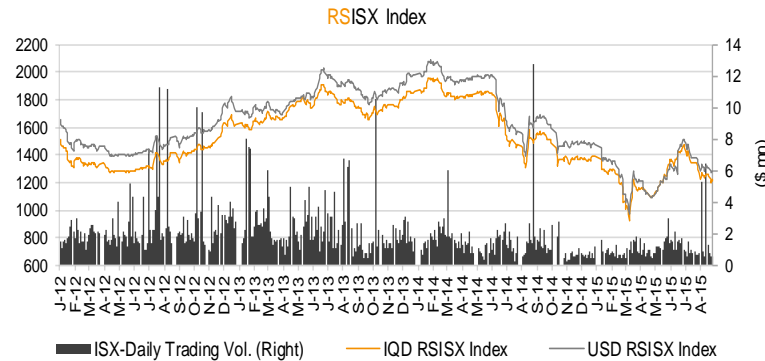

**News from Iraq**

**Politics**

- The five major Kurdistan region political parties agreed on 13 points regarding the presidency of the Kurdistan region, and the outcome of the meeting was very positive, said Fuad Hussein, President Masoud Barzani's chief of staff, in a press conference. (AllIraqNews)
- Kurdish forces backed by U.S.-led coalition air strikes drove IS militants out of 10 villages in Iraq's Kirkuk province on Wednesday in an offensive to secure their territory in the north, Kurdish military sources said. The assault began at dawn in the Daquq area, around 175 km (110 miles) north of the Iraqi capital Baghdad. By evening, Kurdish forces had taken an area of around 24 square km, the sources said. (Zawya)

**Economics**

- The International Monetary Fund, announced on Wednesday that Iraq reserves stand at \$68bn compared to \$66bn last year. Prime Minister Haider al-Abadi stressed on Wednesday that there is no fear on the dinar exchange rate against the dollar, noting to the existence of fraud and conspiracy to influence the current situation. (Iraqi News)
- Iraqi Kurdistan said on Thursday it expected to begin making regular payments to oil-exporting companies in the first half of September, in an apparent attempt to reassure foreign oil companies operating in the autonomous region. Its Ministry of Natural Resources said in a statement that \$75-\$100mn of revenue from its direct crude oil sales would be allocated as payment on account to the companies. (Zawya)

**ISX - Company Announcements**

- The shares of The Light Industries (ITLI) resumed trading today (Aug. 27, 2015) after they approved 2012 and 2013 annual financial results. The capital increase suggestion through 50% rights issue wasn't approved.
- Investment Bank of Iraq (BIBI) will hold its AGM\* on Sep. 5, 2015 to discuss and approve 2014 annual financial results, electing new board members and distributing cash dividend. ISX will suspend trading of BIBI starting on Aug. 30, 2015.

*\*(Please note that the ex-date for capital increases and dividend distributions is referred to as "Trading-Suspension day" which is normally one week before the General Assembly Meetings.)*

The number of traded shares was 653mn and the trading volume was IQD821mn (\$668K).

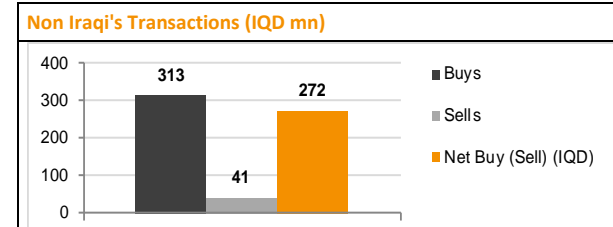
10 out of 36 traded listed stocks' price increased while the prices of 14 stocks decreased, and the price of remaining 12 stocks haven't changed.
